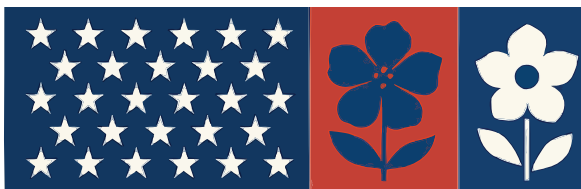

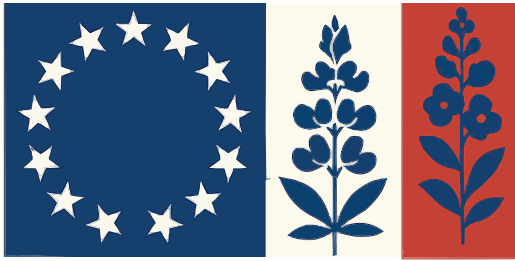

General Show Rules

1. This flower show conforms to the standards established by National Garden Clubs, Inc. (NGC). The *Handbook for Flower Shows* (HB), as updated with revisions posted on the NGC website, is the authority for all issues not covered by the schedule which is the "Law of the Show." An updated copy of the *HB* may be downloaded from the NGC website at gardenclub.org.
2. All members of the Wisconsin Garden Club Federation (WGCF) may enter the Design and Horticulture Divisions.
3. In an NGC Patriotic Show, the nation's flag will be displayed properly and predominantly by the Staging Committee. The USA flag and other national flags cannot be used in designs. Symbolisms—such as bunting—of the flag may be used. The flag cannot be used as part of a costume, an athletic uniform or embroidered on cushions or handkerchiefs.
4. Entries in the Design Division must pre-register July 15, 2024, with the Design Entries Chairman, **Liz Murken** at lizmurken@gmail.com or 920-379-4194. The Design Entries Chairman will provide and place all entry cards for the design classes.
5. No pre-registration is required for horticulture entries. Horticulture entry cards will be available from **Maureen Wild Gordon** at wildgordonmaureen@gmail.com or 608-287-6501 on June 1, 2026. **Horticulture exhibitors should fill out entry cards in advance in waterproof ink or typed.** Additional horticulture entry cards will be available at the show.
6. Each exhibitor is limited to one entry per class except in the Horticulture Division. Exhibitor may make more than one horticulture entry per class if each is a different species, variety, cultivar, type or color.
7. **All exhibits will be accepted from 6 to 9 AM, Thursday, August 13, 2026 in the Grand Champion Hall.**
8. Each Division's Classification Chairman will check exhibits for conformity to the schedule before judging, and can disqualify any entry not conforming to the schedule or not of flower show quality. Final determination for conformance is the judges' responsibility.
9. Judging will begin promptly at 10 AM by NGC Accredited Judges. Only the General Chairman, Classification Chairmen, Judges and Clerks will be allowed on the show floor during the time of judging. Judging will be by the NGC Standard System of Awarding, *HB* p. 5 and any additions found on the NGC website. The General Chairman and Classification Chairman for each division are available during judging for possible consultations.
10. All blue ribbon winning exhibits must be signed and dated by an NGC Accredited Judge on the judging panel. All non-blue ribbon exhibits scoring 90 and above must be so designated on the entry card, signed and dated by an Accredited Judge on the judging panel. All other entry cards must be initialed by an Accredited Judge on the judging panel.
11. Decisions of the judges are final. Awards may be withheld if not merited.
12. There must be an emphasis on **fresh** plant material. No artificial plant material is permitted in any exhibit in any division.

(General Show Rules continued)

- Plants on Wisconsin's Endangered or Threatened Species List must be grown by exhibitor. Plants on the Invasive List will not be accepted.
- All personal property should be clearly labeled. Floral Designers of Wisconsin will exercise all possible care of exhibits and will not assume any responsibility for loss or damage.
- Exhibits must remain in place until the flower show closes. Exhibits/properties must be removed between 7 and 9 AM on Monday, August 17, 2026 from Grand Champion Hall.

National Garden Clubs, Inc. Awards

Division I - Design Awards

General Requirements: A minimum of four exhibits per class. There are two sections of three classes each for a total of 24 exhibits. Each exhibit is the work of one individual. Only one Design Division Award may be offered in any NGC Flower Show. (See *HB*, p. 42.)

Holiday Excellence, a Division Award

This award may be offered to the highest scoring blue ribbon exhibit scoring 95 or more in the entire Design Division entered by an individual. Rosette of red ribbons. **One** may be awarded. (See *HB*, p. 42.)

(Awards continued)

Designer's Choice Award, a Section Award

This award may be offered to the highest scoring blue ribbon exhibit scoring 95 or more in **Section A, Classes 1, 2, and 3**. Twelve exhibits are required. Award is a rosette of purple ribbons. **One** may be awarded. (See *HB*, p. 42.)

Table Artistry Award, a Section Award

This award may be offered to the highest scoring blue ribbon exhibit scoring 95 or more in **Section B, Classes 4, 5, and 6**. Twelve exhibits are required. The award is a rosette of burgundy ribbons. **One** may be awarded. (See *HB*, p. 43.)

Division II – Horticulture Awards

Award of Horticultural Excellence, a Division Award

This award may be offered to the highest scoring Blue Ribbon exhibit, scoring 95 or more and correctly named entered by an individual in the entire Horticulture Division. Award is a rosette of green, orange, and blue ribbons, **One** may be awarded. (See *HB*, p. 40.)

Award of Merit, a Section Award

This award may be offered to the highest scoring Blue Ribbon exhibit, scoring 95 or more and correctly named in **Section A, Classes 1 to 9; Section B, Classes 10 to 13; Section C, Classes 14 to 25; Section D, Classes 26 to 29; and Section E Classes 30 to 33**. The award is a rosette of orange ribbons. **Five** may be awarded. (See *HB*, p. 41.)

Arboreal Award, a Section Award

This award may be offered to the highest scoring Blue Ribbon exhibit, scoring 95 or more and correctly named in **Sections F, Classes 34 to 36 and Section G, Classes 37 to 39**. Award is a rosette of green ribbons. **Two** may be awarded. (See *HB*, p. 40.)

Grower's Choice Award, a Section Award

This award may be offered to the highest scoring Blue Ribbon exhibit, scoring 95 or more and correctly named in **Section H, Classes 40 to 44; Section I, Classes 45 to 48; and Section J, Classes 49 to 51**. Award is a rosette of dark green ribbons. **Three** may be awarded. (See *HB*, p. 41.)

Division III – Education Exhibits Awards

Educational Top Exhibitor Award, a Division Award

This award may be offered to a Blue Ribbon exhibit scoring 95 or more if all NGC Top Exhibitor Requirements for the Educational Award are met. **Exhibits 1 and 2** are eligible. Only **one** is awarded. Rosette is of brown and white ribbons. (See *HB*, p. 43.)

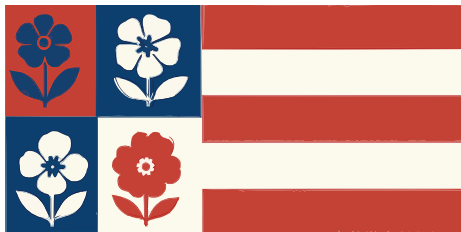
Division I – Design Rules

1. The NGC Exhibit Policies are printed in the *Handbook for Flower Shows*, Chapter 7 Exhibiting in the Design Division, NGC Policies and Guidelines.
2. Some plant material – fresh and/or dried – must be used in every exhibit. Plant material and non-plant material permitted and not permitted in the Design Division are printed in the *HB*, Chapter 7.
3. Fresh plant material may not be treated in any manner. Dried plant material, including wood, may be treated unless restricted by the schedule.
3. Advance registration with the Design Entries Chairman is required by **July 15, 2026**. An exhibitor may enter as many classes as desired, but may make only one entry in a class. To pre-register, contact **Liz Murken** at lizmurken@gmail.com or **920-379-4194**.
4. The exhibit entered into competition must be the work of only one (1) exhibitor and exhibitor's name must appear on entry card.
5. If the designer is unable to fulfill the assignment, it is the designer's responsibility to provide a substitute.
6. If the Designer is unavailable to transport and/or set up his/her completed design, a substitute person may enter the exhibit for the designer. The designer may receive exhibiting credit if needed.
7. All plant material used in the design must be identified on card – 3" x 5" – provided by the exhibitor and included with the entry tag.
8. When Design techniques are required, they must be listed on a card.
9. Plant material, including foliage, uncut fruit and vegetables, flowers and branches are permitted.
10. Plant material need not have been grown by designer.
11. A single flower is not a design. Container-grown plants are fresh plant material and are permitted in the Design Division where appropriate, but are **not** considered a floral design.
12. Landscapes, scenes or anything representing actual items of clothing, person, animal, etc., are not considered acceptable in the Design Division.
13. Religious symbols used in a design must be displayed in a respectful manner.
14. The following are permitted: sea fans, coral, sponges, bones, antlers, nests and naturally shed feathers from non-endangered species.
15. The following are not permitted: treated fresh plant material, artificial fruit, artificial flowers or foliage, prepared food or candy, cut fresh fruit and vegetables, lighted candles, live or taxidermy insects or animal.
16. American and other national flags are not permitted.
17. Use of components other than plant materials in design should be checked with the *HB*, pp. 80 and 81, for conformance.
18. The exhibitor is required to conform to the stated description and limitations of the Design Type, if named in the class.

(Division I – Design Rules continued)

19. Rules for Design Types, Advanced Design Types, Table Designs and Table Appointments are printed in the *HB*, Chapter 7.
20. Designer is on her/his honor that the design being entered has not been previously entered or previously judged in an NGC flower show.
21. The Scale of Points for the Design Division is listed in this schedule on page 8. (See *HB*, p. 130.)
23. Exhibitors may **not** remove any comment card placed by the Judges until the show closes.

Division I – Design Sections and Classes



"In the Traditional Manner"

Eligible for Award of Design Excellence, a Division Award

Section A. "Star Spangled Banner"

Eligible for Designer's Choice Award

Class 1. "O! Say Can You See"

(4 entries)

AN AMERICAN TRADITIONAL LINE MASS DESIGN that conforms to the characteristics of American Tradition styles. Linear pattern established and enhanced and strengthened by additional plant materials. Massed plant material emphasizes the center of interest but does not obscure the linear pattern. The design's line can be straight, angular or curved. The orientation of the design can be vertical, horizontal or diagonal. Staged on a gray platform 41" from floor provided by the Staging Committee. Space allowed is 24" wide by 32" high and 20" deep. Staging panel and underlay required and to be provided by exhibitor. Designer's choice of plant materials and components. (See *HB*, p. 71.)

Class 2. "Rockets' Red Glare" (4 entries)

AN AMERICAN TRADITIONAL LINE DESIGN that conforms to the characteristics of American Tradition styles. Great restraint in the quantity of plant materials used. Linear pattern is dominant and can be vertical, horizontal, crescent, S-curve or zig-sag. Staged on a grey 18" square pedestal that stands 36" from the floor and is provided by the Staging Committee. Space allowed is an 18" gray square. Maximum height allowed is 32". Exhibitor must provide an underlay. Designer's choice of plant materials and components. (See *HB*, p. 71.)

Class 3. "Bombs Bursting in Air" (4 entries)

AN AMERICAN TRADITIONAL MASS DESIGN that conforms to the characteristics of American Tradition styles. Large quantities of plant material that is integrated (not grouped) with a closed silhouette. Staged on a gray platform 41" from floor provided by the Staging Committee. Space allowed is 24" wide by 32" high and 20" deep. Staging panel and underlay required and to be provided by exhibitor. Designer's choice of plant materials and components. (See *HB*, p. 71.)

Section B. "Steeped in Tradition"

Eligible for the Table Artistry Award

Class 4. "Welcoming Veterans Home" (4 entries)

AN INFORMAL FUNCTIONAL TABLE for two. Casual table planned and set for actual food service. Convenience and sense of order must prevail. A decorative unit must be included. Coordination of components must be balanced within the allotted space. Staged on a black cloth-covered 36" round table, 30" from floor provided by the Staging Committee. Exhibitor must provide an underlay. Designer's choice of plant materials and components. (See *HB*, pp. 76-77.)

Class 5. "4th of July Celebration" (4 entries)

AN INFORMAL FUNCTIONAL TABLE for four. An informal alfresco (outdoor) dining experience planned and set for actual food service. A decorative unit must be included. Staged on a 36-inch square platform that is 18" from the floor and covered with a black cloth provided by the Staging Committee. Exhibitor must provide an underlay. Designer's choice of plant materials and components. (See *HB*, pp. 76-77.)

Class 6. "Celebrating 250 Years" (4 entries)

A SEMI-FORMAL BUFFET TABLE for four or more. Components conveniently and logically placed for ease of self-service. At least one (1) serving piece required. A decorative floral unit in proportion to the space allotted must be included. Staged on a black cloth-covered table that is 72" (6') long by 30" wide provided by the Staging Committee. Exhibitor must provide an underlay. Designer's choice of plant materials and components. (See *HB*, pp. 76-77.)

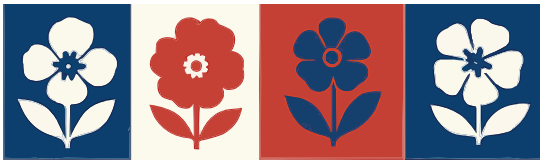

Division II – Horticulture Rules

1. The rules for a single species cut or container-grown specimens are listed in the NGC *Handbook for Flower Shows (HB)*, Chapter 6, or its supplement, *Horticulture Exhibiting and Judging*.
2. If a plant is considered a flowering plant, it should be exhibited as a flowering specimen. Foliage plants may be flowering but should be exhibited as a foliage plant if they are grown and exhibited for their leaves.
3. All entries must be checked by the Horticulture Entries Chairman, **Maureen Wild Gordon**, the day of the show. The chairman reserves the right to make necessary changes in the entry's placement in classes and subclasses.
4. Specimens with a class designation in the schedule may not be entered in the "Any Other Worthy Named Specimen" class.
5. All exhibits must be **fresh** and have been grown by the exhibitor.
6. Exhibit must have been in the possession of the exhibitor for at least 90 days. Three or more plants in the same container must have been grown together for a minimum of six (6) weeks. Arboreal exhibits must have been in the possession of the exhibitor for at least 6 months. Trough exhibits must have been growing together for at least 6 months. Exception: early maturing seeds/transplants; forced bulbs, corms/tubers/rhizomes; and early maturing crops. See the chart in the *Handbook for Flower Shows*, p. 55 for specifics.
7. **Exhibitor should fill out entry cards in advance with waterproof ink or typed.** For a correctly completed card see *HB*, p. 56. Entry cards are available before the show from the Show Chairman and additional cards will be at the show.
8. Plant material must be in its natural state and may not be altered by application (treatment) of oil or commercial "shine" products that change the natural appearance. No wiring of specimens is permitted.
9. **Exhibitor should bring each cut specimen to the flower show in a clear transparent, colorless, glass bottle.** Wedging material (bubble wrap) will be available if needed.
10. Cut specimens should not have foliage below the water line, except for *Gladiolus*.

(Division II – Horticulture Rules continued)

11. Only foliage and/or flowers naturally grown and still attached to the specimen are permitted. Unattached foliage is never included with a cut bloom specimen.
12. Each exhibitor is responsible for the complete and correct labeling of entries (binomial name: genus, specific epithet, cultivar) and the common name, if possible. A plant must be identified by its binomial name or its currently accepted scientific identification to be eligible for a Top Exhibitor Award. Common names may be added following binomial name. See powo.science.kew.org for help. (See Horticulture Awards on page 4.)
13. An exhibitor may enter as many exhibits in any one class, or subclass, as the schedule permits. However, each exhibit must be a different cultivar, color or type.
14. Double potting permitted. Inner pot must not be visible.
15. Maximum size of container for container-grown plants is 12".
16. Top dressing such as pebbles, sand etc. is permitted on container-grown plants.
17. Cut branches/stems not to exceed 30" from apical tip of specimen to cut end.
18. The Horticulture Classification Committee Chairman and/or General Show Chairman are free to subdivide classes by color, form, size, cultivar or other distinguishing characteristics.
19. The Scales of Points for Horticulture are in *HB*, p. 129, and page 12 of this schedule.

Class 50. Planter (grouping of plants in an indoor or outdoor container)

Class 51. Terrarium (miniature landscape in a container with high transparent sides, top is closed or open)

Division III – Education Rules

1. Education Exhibits may be the work of more than one individual or organization unless a Student Judge or an Accredited Judge seeking exhibiting credit for preparing an educational exhibit.
2. Names of exhibitors may appear in the schedule **only** if the exhibits are not being judged.
3. An exhibit must occupy a minimum of eighteen (18) square feet of surface area.
4. Some plant material is required. No artificial plant material is permitted.

7. Each exhibit will be staged on tables 72" inches long x 30" deep, draped in black, provided by Staging Committee.
8. Exhibits are competitive if competing for awards or non-competitive if not judged. The Scale of Points for Education Exhibits listed below and in the *HB*, p 131 will be used to judge the exhibits.

Exhibit will explore native plants and/or indigenous planting practices.

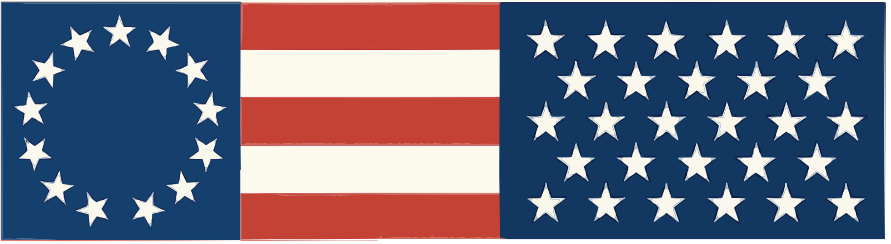

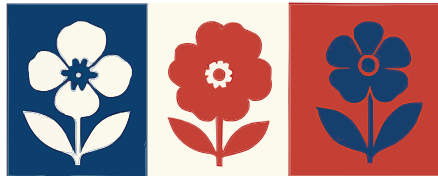
